Hello Mr. Tim McGee, Chief Executive Officer of the LSBC,

1. I want to know Mr. McGee from you, as to what you intend to do about the slanderous and libelous letter of Mr. D. Ross McGowan, of which I attach a copy, who makes serious false allegations against me.
2. The most serious allegations that has potential ramification is found at page 1 para. 2, where Mr. McGowan states for the readers of his letter that, "With respect to Mr. Gaffney, we raise caution that his status could escalate to violent behaviour..." And Mr. McGowan states at page 3 of para. 3, that "Mr. Gaffney should be considered unstable and potentially dangerous".
3. Mr. McGowan is implying that I am a threat to anyone who comes into contact with me, which is untrue. Thus it is reasonable to say that anyone coming into contact with Mr. McGowan's letter of Oct. 31, 08, whether inadvertently or advertently, would naturally want to get me arrested, since his statement, being a member of the bar, and being a partner with Borden Ladner Gervais, carries a lot of weight.

In fact, due to Mr. McGowan's reckless allegations to Mr. Stephen Alsace of CIBC legal department, CIBC did send me a letter in November and December 2008, threatening me with trespass should I enter any CIBC branch to pay my mortgage and my CIBC personal loan. Imagine the outrageous demands made on me by CIBC due to Mr. McGowan's letter, in order for I to default both on my mortgage and my CIBC personal loan? It begs the question what CIBC was prepared to do, had I gone in their financial institution?
5. Subsequently Mr. McGowan's letter affects me directly. Further due to the concern with my safety and security, I cannot let Mr. McGowan's allegations stand as being true, therefore I respectfully ask you Mr. McGee to please let me know what you intend to do with Mr. McGowan and his letter.

Due to Mr. McGowan's legal advise to CIBC, CIBC saw fit to alter postal money orders, without my authorization and knowledge, payable to CIBC Mortgage Corporation Inc. and used the money orders for a purpose other than what it was intended for. This of course, as you know is a criminal offence to alter the face of a postal money order.

If I do not hear from you on this matter, I will reasonably conclude that Mr. McGowan's letter did influence you and in fact the letter has had the effect that Mr. McGowan intended the letter to have on its readers.
