I advise that your complaint about Keith Oliver has been referred to me for review and assessment.

I have now had the opportunity to review your complaint material. I apologize for the delay in doing so.

As I understand it, your complaint about Mr. Oliver is that he failed to respond to your correspondence dated February 11, 2008 and November 3, 2009, wherein you request a copy of the Statement of Adjustments and other documents in connection with a conveyance of Mr. and Mrs. Gaffney's property located at 312-450 Bromley Street, Coquitlam (the "Property"). In response to your request, Mr. Oliver advised you by letter dated February 13, 2008 (and on an earlier occasion on October 16, 2007) that he would not be providing this information to you as you were not counsel of record for Mr. Gaffney. In the absence of any indication that you were acting as counsel for Mr. Gaffney in relation to this matter,  $(\blacksquare)$  was nothing inappropriate in Mr. Oliver declining to provide the requested documentation.
